S.R.O.No.687/80 – In exercise of the powers conferred by section 3 of the Kerala Essential Articles Control (Temporary Power) Act, 1961 (3 of 1962) the Government of Kerala hereby make the following order further to amend the Kerala Raw Cashewnuts (Procurement and Distribution) Order, 1977, issued under No.4001/F3/77-3/ID/dated, the 21st April, 1977 and published as s.R.O.No.345/77 in the Kerala Gazette Extraordinary No.242 dated, the 21st April, 1977, namely:-

1. Short title and commencement (i) This Order maybe called the Kerala Raw Cashewnuts (procurement and Distribution) Amendment Order, 1980.
2. It shall come into force atonce
3. Amendment – In the Kerala Raw Cashewnuts (procurement and distribution) order, 1977, after clause 3, the following clause shall be inserted, namely:-

3A Disposal of Raw Cashewnuts in the possession of Government Departments, and Corporations or companies owned or controlled by Government.

- (1) Notwithstanding anything contained in Clause 3, the Raw Cashewnuts produced by or in the possession of,
 - (i) Any Government Department; or
 - (ii) Any Corporation or company, owned by order under the control of the Government, shall be sold to the Kerala State Cashew Development Corporation Ltd., Quilon, at the market rate notified by the Government under clause 4.
- (2) A Government Department corporation or company referred to in sub-clause(i) which has any stock of raw cashewnuts for sale, shall intimate the fact to the Kerala State Cashew Development Corporation ltd. Quilon.
- (3) On receipt of such intimation, the Kerala State Cashew Development/corporation Ltd., shall the purchase of the Raw Cashewnuts from the concerned Government Department, corporation or company.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport)

According to Clause 3 (i) of the Kerala Raw Cashewnuts (Procurement and Distribution) Order, 1977 no person shall sell any Raw Cashewnuts except to an agent of the Government authorized by them in this behalf or to a sub agent, it is considered that Raw Cashewnuts in the possession of State Government Departments and corporations and companies owned or controlled by the State Government should be made available to the Kerala State Cashew Development Corporation Limited. The amendment is intended to achieve this object.
