- 1. They will be paid the pay and allowances admissible to them in State Government service during the period of training
- 2. The deputation will be subject to the conditions laid down in G.O.9p0303/70/fin,dt,12.5.70

Sanction is also accorded to incur the following expenditure in connection with the training.

- (a) T.A at state rates, dehra dun being treated as the headquarters of the officers
- (b) Equipment allowance of Rs.300/-(rupees three hundred only)each
- (c) Tuition fee of Rs.2,000/- (rupees two thousand only)each
- (d) Caution money of Rs.100/-(rupees one hundred only)each

The chief conservator of forests will arrange to pay the amount to government of India. The expenditure will be debited to "313(e) 1 training and education-plan" in the current years budget.
