### ORDER

The Controller of Accounts in his letter fifth cited has raised certain points on the question of sanctioning the surrender of earned leave, Government have examined the points in detail and are pleased to issue the following clarifications.

### I Payments of House Rent Allowance for the period of surrender leave.

According to G.O.(P) 197/62 Fin. Dated 10-5-1962 House Rent allowance is admissible during periods of leave with allowance (for the first four months of such leave). Government are therefore pleased to clarify that for the period of surrendered earned leave House Rent Allowance will be payable.

# II Compulsory recall to duty

In the G.O. read as first paper above, it has been ordered that an Officer who avails himself of earned leave will be entitled to apply for surrender of earned leave again only after the lapse of 12 months from the date of expiry of the period of earned leave to which the previous surrender was related. Accordingly, in cases of compulsory recall in duty the period of 12 months will be counted from the date of expiry of the earned leave as originally sanctioned and not from the date of expiry of the balance period of leave which the officer will be allowed to enjoy after the compulsory recall to duty.

The amount of leave allowance payable for the period of the surrendered leave will be equivalent to the leave salary and allowances for the first 30 days from the date on which the officer availed himself of the earned leave irrespective of the fact whether he was allowed to enjoy the earned leave sanctioned in full or not due to compulsory recall to duty.
