Consequent on the creation of the post of Principal Chief Conservator of Forests as per the G.O. read above the work between the Principal Chief Conservator of Forests and Chief Conservator of Forests is reallocated as under:-

### PRINCIPAL CHIEF CONSERVATOR OF FORESTS

- 1. Establishment matters including disciplinary cases of IFS Officers and Officers of and above the rank of Dy. Conservator of Forests.
- 2. Forest Policy.
- 3. Co-ordination.

#### CHIEF CONSERVATOR OF FORESTS (WILD LIFE)

- 1. Wild life Administration including Sanctuaries & Natural Parks.
- 2. Biosphere Reserve
- 3. Establishment matters including disciplinary case of the staff of Wild Life Wing.

#### **CHIEF CONSERVATOR OF FORESTS (VIGILANCE)**

- 1. All Vigilance enquiries.
- 2. Monitoring Forests of Offence cases.
- 3. Establishment matters including disciplinary case of staff in the Vigilance Wing.

#### CHIEF CONSERVATOR OF FORESTS (SOCIAL FORESTRY)

- 1. All Social Forestry activities under (a) World Bank Project.
- 2. N.R.E.P and R.L.E.G.P.
- 3. Rural Fuel Wood Scheme.
- 4. Centralised nursery scheme.
- 5. Publicity and Exhibitions.
- 6. Library and Museums.
- 7. Establishment matters including disciplinary case of staff in the Social Forestry Wing.

## **CHIEF CONSERVATOR OF FORESTS (PROTECTION)**

- 1. All plan schemes.
- 2. Working plan and Research Circles.
- 3. Civil Works
- 4. Forest Surveys.
- 5. Plantations Activities.
- 6. Budget and Accounts.
- 7. Training Programmes.
- 8. Establishment matter including disciplinary cases of staff in the plantation and Research Circle.
- 9. Residuary matters not allotted to any other Chief Conservator of Forests.

When the Principal Chief Conservator of the Forests is away from the Headquarters or absent from duty, the Senior most Chief Conservator of Forests in the Headquarters may attend to urgent items of work that need the decision of the Principal Chief Conservator of the Forests.
