ORDER

According to rule 16 of the study Leave Rules in Appendix VI, Kerala Service Rules if an officer resigns or retire from service without returning to duty after a period of Study Leave or within a period of three years after such return to duty he shall refund double the amounts of leave salary study allowance cost of fees, traveling and other expenses, if any incurred by the Government, drawn by him for the period of Study Leave together with interest thereon etc. These rules were framed on the lines of the Study Leave Rules of the Government of India. Now the Government of India have amended their Study Leave Rules to the effect that the amount of penalty recoverable in such cases should be the actual amount of leave salary study allowance, cost of fee, traveling and other expenses interred together with interest thereon. The decision of the Government of India is a great financial benefit to the offices concerned as the amount of penalty is reduced 50% of that now recoverable under the rules. The Government have therefore decided to adopt the decision of the Government of India and amend the study Leave Rules in Appendix VI Kerala Service Rules on that basis. Accordingly the following notification is hereby issued:----

the Government of Kerala hereby makes the following amendment to the Kerala Service Rules namely:-

In the said rules, in Appendix VI.

- 1. In the Note below sub rule (2) of rule 15,
 - For the words "Double the amount" occurring in the first time, the words "The actual amount" shall be substituted.
- 11. In sub rule (1)of rule 16,
 - (1) for the words "double" the amount" occurring in line, the words "The actual amount" shall be substituted.
 - (2) For the provisos, the following shall be substituted, namely:Provided that the Government may order that nothing in this rule shall apply to
 a Government servant who, on return to duty from Study Leave is permitted to
 retire from service on medical grounds.
