ORDER

An Ex-cadre post of Chief Conservator of Forests (Working Plan & Research) is created in the scale of pay of Rs.37400-67000 GP-10000 by keeping in abeyance the cadre post of Conservator of Forests (Working Plan & Research) and the post is declared equivalent in status and responsibility to the cadre post of Chief Conservator of Forests (Southern Circle), Kollam under Rule 11 of IFS (Pay) Rules 2007.
