## ORDER

- 1. Sri.A.S.Anathasubramoniam, Divisional Forest Officers, Kottayam and Assistant Conservator of Forests is promoted as Deputy Conservator of Forests on Rs.500-800 and posted as Silvicultural Research Officer, Trichur. Sri. N.Rajeswaran Nair, Deputy Conservator of Forests now working as Silvicultural Research Officer is reverted as Assistant Conservator of Forests and posted as Divisional Forest Officers, Kottayam vice Sri.Ananthasubramoniam promoted.
- 2. The rank of Sri.Ananthasubramoniam among Assistant Conservator of Forests was just above Sri.V.Sukumaran Nair prior to 2-9-1965 on which date orders were issued as per the G.O. read above reducing his rank among Assistant Conservator of Forests by two places. According to the revised rank his place is just below Sri.T.J.Abraham. Eight of his juniors have been promoted as Deputy Conservator of Forests. His case for promotion was not considered at the due time as the charge against him were pending. Now that the charges have been finalized and punishment imposed, Government consider that he should be promoted forthwith and his rank among Deputy Conservator of Forests fixed with reference to his rank among Assistant Conservator of Forests after it was

reduced by two places. Government therefore order in relaxation of Rule 27 of the General Rules that Sri.Ananthasubramoniam will take rank among Deputy Conservator of Forests just below Sri.T.J.Abraham, Deputy Conservator of Forests.
