NOTIFICATION

**S.R.O.No 539/77**—In exercise of the powers conferred by subsection (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby makes the following amendment to the Kerala Service Rules, namely:--

AMENDMENT

C.S.No. 325/77

In the said rules, in section II of Appendix VII----

- (1) in rule 13, the following sentence shall be inserted at the end, namely:-  
“Special Casual Leave under this rule may be granted on more than one occasion in a calendar year, if needed”.
- (2) after rule 15, the following rule shall be inserted namely:--  
“16 Disabled State Government employees shall be eligible for special casual leave for a maximum period of 15 days at a time (including the time spent in transit both days) to attend Article Limb Centre and stay in hospital for replacement/treatment of their artificial limbs. Special casual leave under this rule may be granted on more than one occasion in a calendar year, if needed.

## **Explanatory Note**

In the G.O. read as 1<sup>st</sup> paper above Government have ordered the disabled ex-servicemen employed in the State Government Service will be granted special casual leave for a maximum/period of 15 days at a time to go to the Artificial Limb Centre for replacement/treatment of their artificial limbs. The Director of Animal Husbandry in his letter read as 2<sup>nd</sup> paper above, has requested Government to extend the benefit to disabled State Government employees as a whole. Government have considered the request and the above notification is issued to include necessary provision in the rules.
