Sub:-Flag Day, 1978-Observance of.

The Armed Forces Flag Day will be observed this year on 7th December 1978. The observance of Flag Day provides an opportunity to all of us to remember the members of our Armed Forces, who at constant risk to their lives and under most trying conditions, are doing yeoman service for our country. They also serve the people during floods, drought and other natural calamities. They are assigned for International Peace Missions and thus enhance the prestige of our nation.

- 2. Contributions received through sale of flags on Flag Day are utilised mainly for financial assistance to Ex-Servicemen, T. B./ Leprosy patients, disabled Ex-Servicemen and widows and children of servicemen dying in action. With the number of Ex-Servicemen increasing every year, there is imperative need for more funds. Thus large amounts are being spent on such humanitarian causes every year.
