ORDER

In the G.O. read as second paper above, Government have issued orders increasing the maximum number of Casual Leave in a year for Government Employees from 15 to 20 and abolishing the system of Restricted Holidays. It has also been ordered that the Restricted Holiday on 7-1-1978 will be treated as Casual Leave for those who have availed themselves of the Restricted Holidays. It has been brought to the notice of the Government that some of the employees have availed of the Restricted Holiday on 7-1-1978 by prefixing or suffixing to the regular leave. But Casual Leave cannot be combined with regular leave. Further, such conversion of the Restricted Holidays on 7-1-1978 already availed of will result in the loss of another Public Holiday viz., Sunday on 8-1-1978 to those employees causing much hardship to them, which was not contemplated. Government are therefore pleased to order, in relaxation of the orders contained in the G.O. second cited, that past cases where the Restricted Holiday on 7-1-1978 was allowed to be prefixed and suffixed to regular leave, need not be reopened and that in those cases the total number of Casual Leave will be reduced by one day for the Calendar Year.
