In Appendix VII to the said rules, under the heading "Section II---Special Casual Leave", after rule 16, the following rule shall be inserted, namely:-

"17 Teaching staff of Government Colleges accompanying students' teams for University Youth Festival organized by the University Union and teaching staff of schools who accompany the students' teams for Youth Festivals, sports meets and sports coaching camps conducted at State level shall be granted special casual leave for the days of the events and the minimum period required for to and from journeys subject to the condition that the total period of such special casual leave shall not exceed 15 days in a calendar year".

Explanatory Note

The Principal, T.D. Medical College, Alleppey in his letter read above requested Government to consider whether members of teaching staff in Government Colleges may be allowed the facility of special casual leave for the purpose of accompanying students teams to the University Festivals organized by the University Union in view of the decision taken by the Syndicate to grant the facility to the teaching staff of affiliated colleges. The Director of Public Instruction suggested that the teaching staff of schools may be granted the benefit for Youth Festival sports meets and sports coaching camps.
