Census 1981—Facilities and concessions to the Staff engaged for the Census Work—Orders Issued

ORDER

C In the circumstances reported by the Director of Census Operations, Kerala, Government are pleased to issue the following orders regarding the facilities and concessions to be given to the staff engaged for the work in connection with the Census, 1981.

- 1. The teachers and employees of local bodies and other Government Offices appointed as Supervisors and enumerators should not be transferred out of their existing posts from the date of their appointment as Supervisors/enumerators till the Census work is over i.e. from October 1980 till 15th March 1981 under any circumstances except under the unavoidable contingency like promotion or reversion. When any such transfers are ordered the Officer ordering such transfer should communicate a copy of that order to the District Collector and Principal Census Officer of the District.
- 2. No leave other than casual leave should be granted to the personnel appointed as Supervisors and enumerators during the crucial period i.e. from 1st October, 1980 to 15th March 1981 except on medical grounds. Even in the case of leave on medical grounds the competent authorities should sanction leave only in really deserving cases after satisfying themselves that the Census work will not be adversely affected. They should consult the District Collector

and Principal Census Officer of the district before sanctioning the leave and this fact of consultation should also be recorded in the orders sanctioning the leave.

- 3. The Heads of institutions/offices will permit the staff drafted for census work to be absent from duty for attending the census training classes and the period spent for this purpose will be treated as duty. The Census Charge Officers will communicate a copy the training programme to the concerned heads of institutions/offices in advance for information and reference.
- 4. The Supervisors and enumerators engaged for the 1981 Census will be allowed the concession of absenting themselves from their institutions/offices on census duty for half a day either in the orenoon or in the afternoon on all working days during the period from 9th February to 21st February 1981 and for the full day on all working days from 22nd February to 28th February 1981 for the enumeration work.
- 5. In respect of Supervisors and enumerators in the hilly tracts i.e. the taluks of Devicolam, Peermade, Udumbanchola, North Wynad, South Wynad, the Agali, Pudur and Sholayur Villages (formerly Attapadi I, II and III villages) of Mannarghat taluk, the Nilambur, Chungathara, Amarambalam, Kalikavu, Karuvarakundu, Thuvoor and Edakkara villages of Ernad taluk and Kanthalad, Pannikkottur and Peruvanna villages of Quilandy taluk, they will be allowed to be absent from their institutions/offices on census duty for half a day either in the forenoon or in the afternoon on all working days during the period from 9th February 1981 to 14th February 1981 and for full day on all working days during the period from 15th February to 28th February 1981 for the enumeration work.
- 6. The enumerators will also be allowed to absent themselves from their institutions/offices on census duty for the whole day for 5 days from 1st March to 5th March 1981 for the revisional round. The Supervisors will be allowed to absent themselves from their institutions/offices on census duty for the whole day for 6 days from 1st March 1981 to 6th March 1981 for the revisional round and for checking and handing over the census records to the Charge Officer.
- The Director of Public Instruction will instruct—(i) all the nongovernment schools to grant all the above concessions to the Supervisors and enumerators drawn from those schools just as in the case of Government Schools.



(ii) the heads of educational institutions will make available suitable halls for the conduct of the Census training classes on request from Municipal Commissioners, Tahsildars, Divisional Forest Officers and if necessary to dispense with any regular class or classes on these days.

All Tahsildars and Regional Deputy Directors of Census Opera-All Tahsildars and Regional Deputy Directors of Census Operations will be provided with a Government vehicle during the period from 1-1-1981 to 8-3-1981. The District Collectors are authorised to requisition the vehicles for this purpose from all Departments of Government except essential services. Immediately on receipt of the requisition from the District Collector, the Department concerned should make available the vehicle to the concerned Census Officer. The Heads of Departments will issue necessary instructions to their Subordinates who are in possession of Government Vehicles to release the same to the District Collector when requisition is made to that effect. The cost of Petrol and Oil will alone be debited against the Census Head of Account in respect of the Government Vehicles utilised for the Census Work.
