ORDER

By the G. O. read as first paper Government introduced a Minority Language Test in Tamil and Kannada, obligatory to the Officers other than Tamilians/Kannadigas, who actually work in the respective language areas. By the G.O. read as second paper the above test was ordered to be discontinued as it was felt that there would be sufficient number of Officers knowing the principle languages in the State to work in the linguistic minority areas. But, subsequently the need for providing alternative arrangements for acquisition of Minority Language qualification by the superseded Officers was brought to the notice of Government and so the minority language test was reintroduced by Government by the G. O. read as third cited.

2. The State Institute of Languages, Kerala is conducting a part time Diploma Course in Tamil. As it was represented that those who passed the above Diploma Examination might be exempted from passing the Minority Language Test in Tamil conducted by the Public Service Commission, Government obtained the full particulars of the Diploma Course conducted by the GPT. 3/3472/MC.

State Institute of Languages, Kerala. They found that this diploma course is of a higher standard than the Minority Language Test in Tamil conduced by the Public Service Commission and therefore proposed to exempt those who have undergone the above Diploma course successfully from passing the Minority Language Test in Tamil. The Public Service Commission agreed with the proposal. with the proposal.

3. In the circumstances, Government order that those who have undergone the Diploma Course in Tamil conducted by the State Institute of Languages, Kerala be exempted from passing the Minority Language Test in Tamil conducted by the Public Service Commission.
