Sub: - Plan Works - Review of progress - regarding 735

1. Progress of plan works - General review. 7101

A statement showing the allotment of funds and the expenditure incurred upto the end of July 1980 in respect of the various circles and divisions is enclosed.

Though the total amount is Rs.254.173 lakhs, only an amount of Rs.40,993 has been spent giving a percentage of about 15%. The performance is obviously not at all satisfactory. Though the performance in some Circles and Divisions is good, the same is very poor in many Circles and Divisions. The enclosed tabular statement will reveal the fact. The Conservators and Divisional Forest officers are requested to devote their personal attention to show better progress.
