NOTIFICATION

S.R.O.No. 540/79---In exercise of the powers conferred by subsection (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following amendment to the Kerala Service Rules, namely:-

AMENDMENTS C.S.No.355/79.

1. (i) These rules may be called the Kerala Service (Amendments) Rules 1979.

(ii) They shall be deemed to have come into force with effect on and from the 5th day of June, 1978.

- 2. In Part I of the Kerala Service Rules,--
- (i) in rule 84, after the existing proviso, the following proviso shall be inserted, namely:--

"Provided further that no medical certificate shall be necessary for granting commuted leave for a period not exceeding sixty days in continuation of maternity leave":

(ii) after rule 102, and before the existing Note, the following proviso shall be inserted, namely:--

"Provided that no medical certificate shall be necessary for grant of any leave for a period not exceeding sixty days in continuation of maternity leave".

Explanatory Note

In G.O.(P) 490/78/Fin. dated 5-6-1978 orders were issued to the effect that female State Government employees may be granted leave of any kind due including commuted leave if they so desire in continuation of maternity leave up to a maximum of 60 days without production of medical certificate. This amendment is intended to incorporate the orders issued in the G.O. read above.
