ORDER

Shri. M.P.Zachariah, retired Range Officer while working as ranger was under
orders of revision for the period from 10-9-70 to 15-10-1971. This period was counted
for calculation annual increments. The Chief Conservator of Forests has in his letter
no. E6-25161/75 dt. 19-6-1975 ordered to recover the amount of increment
erroneously granted during the reversion period.

2. Shri. M.P.Zachariah has stated in his appeal petition, a read above that the
reversion had actually not taken effect in his case as he was on leave from 20-9-1970 to
10-10-1971. He has pointed out that in the G.O. read above, Government have set
aside the above order of the Chief Conservator of Forests in respect of Shri. C.E.
Rappai. The Petitioner says that he is equally aggrieved and has requested that his
case may also be brought within the purview of the above Government Order.

3. Having examined the matter Government find that the case of the petitioner is
exactly similar to the case of Shri. C.E.Rappai disposed of in the Government Order
read above. Therefore, the orders of the Chief Conservator of Forests in his letter No.
E6. 25161/75 dated 19-6-1975 to recover the amount of increment granted to Shri.
M.P.Zachariah during the period of his reversion are hereby set aside.
