Audit Reports 1964 and 1965 of Government of Kerala - Recommendations -

During the course of examination by the Public Accounts Committee of the Accounts etc. of Government of Kerala for the years 1964-65 a case has come to notice in which a person posing as an official of the Government of India had requested some State Government officers for the issue of certain stores on loan. The State Government Officers issued the stores. Later on it was found that the person was an impostor and it was a case of cheating.

To avoid repetition of such a situation it is desirable that instructions are issued to all concerned that whenever an officer is deputed for obtaining any assistance from the State Government authorities and

the identity of the officer is not known to the State Government Officers concerned, a written intimation in advance should be sent to the State Government and a copy of the same endorsed to the Officer of the Central Government who may produce this document to enable the State Officials to establish his identity.
