O R D E R

In the Government Order read as first paper above, it was ordered that a lease rent of Rs.615/- per hectare per annum will be realised from the Kerala State Electricity Board and other Government owned Commercial undertakings for the forest land leased out to them for three years from 18-12-1981 to 17-12-1984. Further in the Government Order read as 2nd paper above it was ordered to continue the above rate of lease rent to the Kerala State Electricity Board and other Government owned Commercial undertakings for the forest lands leased out to them for the period from 18-12-1984 to 17-12-1987. The Chief Conservator of Forests has in his letter read as 3rd paper above submitted proposals for revision of lease rent with effect from 18-12-1987 to 17-12-1990.

2.Government having considered the proposal in detail are pleased to order fixing lease rent for Kerala State Electricity Board and other Government owned Commercial undertakings at Rs.1300(Rupees One thousand and three hundred only) per hectare per annum for the period from 18-12-1987 to 17-12-90.

3.The Chief Conservator of Forest will take timely action to revise the rate of lease rent for the next three years from 18-12-1990.

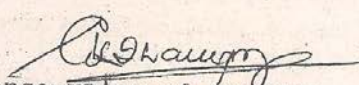
