Forests - Ban on cutting and removal of trees - Restrictions to be continued - Orders issued

ORDER

As per the Circular read as Ist paper above Government banned cutting of trees as welllas wax removal of felled trees in the Stateuntil further orders. In the circular read as 2nd paper above Government have clarified that the ban did not apply to the following cases:-

- 1) Supply of raw materials for Hindustan Newsprint Limited, Velloor.
- ii) Drawing of Transmission lines for which clearance of Government of India under Forest Conservator Act 1980 obtained and orders issued viz. 220 KV line from Idukki to Udumalpet and 220 KV line from Saparigiri to Trivandrum.
- iii) Lower Periyar Hydro Electric Project for which sanction was already issued with the clearm se of Government of India under Forest Conservatomact.
- iv) Supply of bamboos and reeds for the Kerala State Bamboo Corporation.

The Chief Conservator of Forests has now brought to the notice of Government the difficulties experienced by the Forest Department consequent on the issue of the ban order and requested relaxation to. the ban order.

After having examined all aspects of the matter Government are pleased to issue the following orders on the extent of restrictions to be continued in the tree felling operations of the forest Department instead of the blanket ban imposed in the circular read as Ist paper above: -

- I. Natural Forests (in Reserve and Vested)
 - a) The ball of clear felling will continue
 - b) contracts settled for selection felling prior to the imposition of ban on cutting any trees in Forest areas will be honoured strictly in accordance with the terms of the mankask.contract.

Trees felled and lying in coupes or stacked under concluded contracts will be permitted to be removed strictly in accordance with the terms of the contract.

d) Extraction of bamboos and reeds will be permitted. Traditional artisians and Scheduled Tribes will be permitted to extract bamboos and reeds for their use according to general orders in force.

e) Only departmental extraction of dead sandal wood and resewood trees will be allowed.

f) Felling of trees for projects or schemes or other purposes will be permitted strictly according to the terms and conditions prescribed by Government of India in their sanctions under the Forest Conservator Act 1980.

II. Plantations

- A)Clear felling, selection felling, thinning operations etc. will be done following the silvicultural norms scrupulously. Contracts entered into on this basis for felling and removal operations will be honoured strictly in accordance with the terms of the contract.
- b) However, in teak plantations located in sanctuary areas. final felling operation only will be done as Departmental work restricting removal only to 25% of the trees.
- e)Departmental extraction of dead and wind fallen trees in sancturies will be allowed without disturbance to animals.
- III. Occupied areas of Forests From areas in Cardamon Hills Reserve and other forest areas where there is wide spread destruction of trees by settlers, salvage felling are permitted only as a Departmental operation.
- WV. Private lands Passes will be issued for cutting of trees from private lands observing all the provisions of the Kerala Forest Act and the Kerala Preservation of Trees Act 1986.
