The Prime Minister has announced a revised 20-point programme a few days ago. A copy of the programme is enclosed for reference. The revised 20-point programme highlights certain high priority development programmes indicated in the Sixth Five Year Plan and it will therefore be essential to achieve the sectoral targets indicated in the Sixth Plan for the effective implementation of the 20-point programme. The Planning Commission has requested the State Government to set up adequate monitoring arrangements for assessing the progress in the implementation of the programme and to send quarterly progress reports for their review.

Government have considered the quantum and are pleased to order the constitution of a District Level Committee to review the progress of implementation of the schemes under the new 20-point programme with the following composition:-

2. Super. of police
3. Ex. Engineers (Buildings & Roads) in the District
4. Ex. Engineer (Irrigation)
5. Ex. Engineer (Non Irrigation)
6. Ex. Engineers (Public Health Engineering) Dept. in the Dist.

8. Ex. Engineers (Kerala State Electricity Board) in the Dist.
9. Manager, Pt. Industries centre.
10. Deputy/Director of Agri./Pt. Agri. Officer.

13. Pt. Veterinary Officer
14. Asst. Director of Dairy Devpt.
15. Pt. Medical Officer of Health.

2. The District Collector may co-opt. other officers as members of the Dt. Committee, if necessary.

3. The Committee will review the progress of the implementation of the various schemes (Plan and non-Plan) falling within the purview of the 20 point programme every month. The review sheet should be on the basis of the targets financial and physical, fixed for the implementation the schemes at each stage. Copies of the review should sent to the Department of Planning & Economic Affairs by 15 th of the succeeding month.

4. The District Collectors will place copies of the monthly reviews for discussion in the District Development Council meeting once in 3 months. The minutes of the District Development Council relating to the review on the progress of implementation of the 20-point programme should also be sent to Government in the Planning & Economic Affairs Department.
