Read: 1. G.O.Ms.173/61/AD/ dt. 25-2-61. 2. Lr. No.Gl-161/70 from the CCF. Order.

In G.O.ms. 173/Sl/AD/dt.25-2-61, Govt. accorded sanction for the elimination of thondy articles which are not economical to be worked down to the nearest office or Guard Station, if the officer -concerned certified that otherwise it would be a loss to Govt.

The Chief Conservator of Forests has requested Govt. to clarify the monetary limitation in the case of write off that is to be observed by each officer.

Govt. suggest that it would be safer to insist on financial limits as per write off in which case higher officers would also properly be associated

Govt. have examined the matter and are pleased to order that for the elimination of thondy articles the same powers as in the case of write off value are delegated to the various officers relaxing the annual limitation and also fixing the limit in individual cases as given below:-
