O R D E R

In the G.O. read as first paper above, the ratio and pool system for promotion of typists in the non-Secretariat departments was abolished and instead, the typists have been allowed promotion to the U.D. cadre on the basis of the number of years of service. In the letter second cited, the Director of Collegiate Education has requested clarification whether L.D. Typists promoted as U.D. Typists and reverted afterwards due to want of vacancy are eligible for the higher grade on completion of 13 years of service in the L.D. / U.D. cadre together.

2. Government have examined the case in detail. The scheme of time-bound promotion allowed for typists in non-Secretariat Departments is in lieu of the ratio and pool system and is different from the general scheme of grade promotion allowed to the Non-Gazetted Officers and Gazetted Officers on Completion of 13 years of service in the entry grade. There is no stipulation in the G.O. first cited that a L.D. Typist having 13 years of service in that grade alone will be allowed the scale of pay of U.D. typist. It is therefore clarified that a L.D. Typist promoted as U.D. typist and later on reverted to the L.D. cadre for want of vacancy, will be allowed U.D. cadre in terms of the G.O. read above, taking into account the total service put in by him in the L.D. /U.D. Cadre together.

3. This order will have effect from 1-7-1978.
