Sub:-- Public Services—Non Gazetted Officers and Gazetted Officers without adequate Promotional avenues—Benefit of higher grade sanctioned—individual cases of Seniors getting lower pay than junior direct recruits—Individual cases to be considered by Government on merits—Instructions issued.

Ref: -- G.O. (P) 1041/79/ (142) Fin. dated 27-11-1979.

It has been represented to Government that as a result of the grant of higher grade to officers who remain in the entry grade without promotion in the normal course, on completion of 13 years of service in the entry grade, the anomaly of a senior getting lower pay than a junior direct recruit has arisen and that this anomaly may be removed.

- 2. The possibility of a junior hand who is a direct recruit to a particular post getting the higher grade on completion of 13 years' qualifying service, while his senior who is promotee to the post not getting the benefit of higher grade, has been anticipated by Government while issuing instructions for the implementation of the orders regarding grant of higher grade—Vide clause of para 2 of the G.O. under reference.
- 3. It has now come to the notice of Government that stray cases of seniors getting lower pay than their junior direct recruits under the condition stated in para 2 above, consequent on the granting of the benefit of higher grade to such juniors (direct recruits), actually occur.
 - 4. The Heads of Departments are requested to report to Government in the Concerned Administrative Department, full particulars of individual cases, if any, of Senior getting lower pay than a junior direct recruit, in their departments on account of the implementation of the scheme of higher grade. The cases so reported to Government shall be considered on merits. The administrative Departments of the Secretariat are requested to forward the cases with their specific recommendations to the Finance Department.
