## ORDER

According to the G.O. read as first paper above, the scale of Rs. 520-900 will be admissible only to those who are promoted as Fair Copy Superintendents from the category of Senior Grade Typists. In the G.O read as second paper above, it has been clarified that U.D. Typists promoted as Fair Copy Superintendents prior to 1-7-1978, and who were drawing pay in the pre-revision scale of Rs.520-900 sanctioned for the post of Fair Copy Superintendent as per the G.O. cited first, will be allowed to retain in the revised scale of Rs. 450-785 as personal.

- 2. In his letter read as fourth paper above, the Inspector General of Police has sought clarification on the following points:--
- (a) Whether Upper Division Typists who got promotion as Fair Copy Superintendents prior to 1-7-1978, and who would have been actually eligible for promotion to senior Grade, but were posted as Fair Copy Superintendents can be allowed the higher scale of Rs. 520-900 of Fair Copy Superintendents from 1-7-1978.
- (b) Whether Upper Division Typists who have been promoted as Fair Copy Superintendents prior to 1-7-1978, can be allowed the benefit of Senior Grade on or after 1-7-1978 on completion of ten years' service as Upper Div ision Typist reckoning also the service rendered in the post of Fair Copy Superintendent.

The Inspector General of police has also pointed out that in the above cases, if fixation of pay in the Senior Grade and in the scale of Rs.520-900 of Fair Copy Superintendent is not allowed, it will result in the anomaly of juniors getting higher pay than the seniors.

3. The Government have examined the above in detail and are pleased to order as follows:--

- (i) Upper Division Typists who got promotion as Fair Copy Superintendents prior to 1-7-1978 and who would have been actually eligible for promotion to Senior Grade but for their posting as Fair Copy Superintendents, will be allowed the higher scale of Rs.520-900 of Fair Copy Superintendent on 1-7-1978, in the same manner allowed to Fair Copy Superintendents promoted from senior Grade Typists prior to 1-7-1978, ordered in the G.O. read as 3<sup>rd</sup> paper above. However, before allowing this benefit in each case, the eligibility of the incumbents for promotion to the Senior Grade prior to 1-7-1978 should be ascertained from the respective pool administering authorities.
- (ii) Those who were promoted as Fair Copy Superintendents from Upper Division Typists prior to 1-7-1978, and were not eligible for promotion to the Senior Grade then, will be allowed Senior Grade on or after 1-7-1978 on completion of 10 years' service in the Upper Division service in the Upper Division Cadre, taking into account, the service rendered in the post of Fair Copy Superintendent also. From the date they are as promoted to the Senior Grade on or after 1-7-1978, they will also be allowed the higher scale of Rs.520-900 of Fair Copy Superintendent, in the place of the scale of Rs.450-785.
  - 4. These orders will have effect from 1-7-1978.
