Pursuant to the orders issued in the G.O. read above, the following notification is hereby issued.

NOTIFICATION

S.R.O.No. 236/81---In exercise of the powers conferred by subsection (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following Rules further to amend the Kerala Service Rules, namely:-

RULES
C.S.No.384/81.

1. (i) These rules may be called the Kerala Service (Amendment) Rules 1981.
(ii) They shall be deemed to have come into force with effect 29th July,1980.
2. In Part I of the Kerala Service Rules,--
 - (i) for rule 100, excluding the Notes, the following shall be substituted namely:--
“100. A Competent Authority may grant to a female officers maternity leave on full pay for a period of 90 days from the date of its commencement”.

Note 2 under rule 100 shall be omitted.

Explanatory Note

(This does not form part of the notification but is intended to indicate its general purport.)

In G.O.(P) 481/80/Fin. dated 29-7-1980 orders have been issued that a competent authority may grant to a female officer under the State Government maternity leave on full pay for a period of 90 days from the date of its commencement i.e., it shall not be restricted to 8 weeks from the date of confinement as at present. This amendment is intended to give statutory validity to the above orders.
