ORDER

In the G.O read as second paper above, Government issued orders, among other things, allowing higher grade of Rs. 300-450 to Village men who have complete4d 13 years of qualifying service in the entry grade, with effect from 1-7-1979.

2. According to pan 2(iii) of the G.O. read as first paper above, the benefit of higher grade can be allowed only to those who have completed 13 years of qualifying service in the entry grade or post. The secretary, Board of revenue (LR), in his letter cited third, has pointed out that prior to 1972 the post of Village man carried different designations such as Masppadi, Kolkaran, Peon etc. Before 1972, the posts of Village man and Peon were interchangeable and it was only in 1972 that the post of villgeman was separated from the category of last grade servants. Till 1-7-1978 the scales of pay of Village man and Peon were one and the same. With effect from 1-7-1978, Village man was allowed the higher scale of Rs. 290-425. Since the post of Village man was there even before 1972, the secretary, Board of . Revenue has requested to allow grade promotion to this category taking in to consideration the previous service put in by them in different posts such as Villageman,Masappady, Kolkaran, Peon etc., taken together for computing the 13 years of qualifying service for grade promotion on 1-7-1979 or subsequently

3. Government have examined the proposal of the secretary, Board of Revenue (LR) in detail and are pleased to order that all Village man who Were known by different designations prior to 1972, such as Masappady,,Kolkaran, Peon etc. and who have completed 13 years of qualifying service as on 1-7-1979 or any subsequent dates will be eligible for the benefit of higher-grade sanctioned in the G.O read as second paper above irrespective of fact that they were designated differently prior to 1972.

4. These orders will have effect from 1-7-1979.
