## ORDER

In the G.O. read as 1<sup>st</sup> paper above, Government issued orders allowing the benefit of higher grade with effect from 1-7-1979 to all non gazetted Officers who remain in the entry grade on completion of 13 years service without any promotion in the normal course. Detailed instructions for the implementation of the above orders have been issued in the G.O. second cited. In the G.O. third cited it has been clarified that a person who entered Government service as L.D. Typist and subsequently posted appointed as Lower Division Clerk on passing the eligibility test conducted by the Kerala Public Service Commission will be eligible for higher grade in terms of Government orders 1<sup>st</sup> and 2<sup>nd</sup> cited, on completion of 13 years of total qualifying service as L.D. Typist/ L.D Clerk. In the G.O. 4<sup>th</sup> cited Government also ordered that the employees borne on the first nine scales of pay, will be allowed promotion to higher grade or not.

1. The Director of technical Education in his letter 5<sup>th</sup> cited has requested Government to clarify whether U.D. Typist with ten years service and test qualification who have been posted as U.D. Clerks can be granted higher grade on completion of a total service of 13 years as U.D. Typist and U.D. Clerks based on the orders contained in the G. O. read as 4<sup>th</sup> paper above.

2. Government have examined the question in detail and are pleased to order that U.D. Typist who have been posted as U.D. Clerks will be granted higher grade on completion of a total service of13 years in the U.D. cadre reckoning the service put in by them in the U.D. Typist cadre Also in terms of the orders 4<sup>th</sup> cited.

3. These orders will have effect from 1-7-1979 with monetary benefit from 1-7-1980.
