- (i) In rule 72, Note 2 shall be omitted.
- (ii) In rule 75, the provisos, the Explanations and the Notes 1 to 7 shall be omitted.

### **Explanatory Note**

(This is not part of the notification, but is intended to indicate its general purport).

With the introduction of the scheme of surrender of Earned Leave and permission to surrender the entire Earned Leave at one's credit at the time of retirement, cases of refusal of Earned Leave applied for preparatory to retirement and re-employing an officer while on refused leave will not arise. In cases where re-employment of officers is ordered in the exigencies Public Service Rule 100 part III Kerala Service Rules is enough to registered the re-employment pay. Hence the entire Note 2 under Rule 72, Part I, Kerala Service Rules and the entire rule 75 ibid except the first senter become unnecessary. Hence the amendments.
