ORDER

In the Government order read as first paper above, Government sanctioned the benefit of higher grade with effect from 1-7-1979, to all Non-Gazetted Officers who remain in the entry grade for 13 years without any promotion in the normal course. Detailed instructions for the implementation of the above have been issued in the G.O. second cited. In the G.O. third cited, Government also ordered that the employees borne on the first nine scales of pay, will be allowed promotion to higher grade on completion of 13 years' service in that grade, irrespective of whether the grade is the entry grade or not. This benefit was further extended to all Non-Gazetted Officers including those in the scale of Rs. 600-1100, as per the G.O. read as 4^{th} paper above.

2. In this letter read as fifth paper, the District Collector, Palghat has sought clarification whether a U.D. Clerk who got promotion as Head Clerk or as Junior Superintendent for a short period before 1-7-1979 and substained reversion and working as U.D. Clerk on 1-7-1979 or thereafter is eligible for the benefit of higher grade on completion of 13 years of service in the lower post.

3. Government have examined the question in detail and are pleased to order that in the case of those who got promotion for some time and then reverted and are continuing in the entry grade/same grade shall be allowed the benefit of grade promotion, if they have at their credit 13 years of qualifying service excluding the period during which they were holding the higher post on promotion, as on 1-7-1979 or subsequent dates when they complete the prescribed period of 13 years of service for that purpose.

4. These orders will have effect from 1-7-1979.
