**ORDER**

As per the G.O. first cited physically handicapped Government employees were sanctioned a conveyance allowance of Rs. 50 per mensem subject to certain conditions. Accordingly an orthopedically handicapped employee will be sanctioned the allowance on the basis of a medical certificate issued by the Head of Orthopedics Department of Government Civil Hospital and in the case of a blind employee the allowance will be payable on the recommendation of the Head of Ophthalmological Department of a Government Civil Hospital. But subsequently Government have issued orders in the G.O. second cited, constituting Medical Boards in each district for the examination of physically handicapped employees and issue of medical certificate.

In the light of the order 2<sup>nd</sup> read above Government have reviewed the whole matter and order that the medical certificates issued by the Medical Boards alone will be accepted for sanctioning the conveyance allowance.

The orders issued in G.O. (P) 364/80/Fin. dated 11-6-1980 will stand modified to the above effect.
