## **ORDER**

In the G.O. first cited, detailed instructions governing the scheme for the grant of higher grade benefit with effect from 1-7-1979 to those who have completed 13 years of service in a grade without a promotion in the normal course, were issued. Among other things it has been specified in that G.O. that service for computing the 13 years service prescribed for the grant of grade benefit.

- 2. The Registrar of Co-operative Societies, in his letter second cited, has sought clarification whether the period during which increments of an employee are barred without cumulative effect can be reckoned for computing the 13 years'qualifying service prescribed for the purpose of allowing grade promotion.
- 3. Government have examined the question in detail and are pleased to clarify that barring of increments without cumulative effect has the effect of only disallowing the monetary value of the increment during the bar period and not of denying the benefit of the increment due, thereafter, Government are therefore pleased to order that the period during which increments are barred without cumulative effect shall also be reckoned for computing the 13 years of qualifying service prescribed for the purpose of allowing higher grade benefits.
