RECKONING THE SPECIAL PAY GRANTED IN LIEU OF HIGHER
TIMESCALE OF PAY AS PART OF PAY FOR PURPOSE OF
COMPUTING AD HOC D.A – FURTHER ORDERS ISSUED.

ORDER

In the G.O. read above, the State Government Officers in the pay range of Rs. 1762 to Rs. 2750 have been sanctioned adhoc D.A with effect from 1-9-1982, at 54% of their basic pay at 200 points, minus Rs. 820 subject to a maximum of Rs. 345 p.m. as one time measure over and above the regular D.A. increase sanctioned in G.O. (P) 194/82/Fin. dated 19-4-1982. In para 2 of the G.O. cited, it has been stipulated that the adhoc D.A. will be admissible only on the basic pay of the officers concerned without including special pay, deputation special pay, special allowance or any addition to pay under any other nomenclature.

2. It has been represented that the special pay of Rs. 200 granted to the post . Additional Secretaries to Government in lieu of a higher time scale of pay may also be reckoned for computing the one time increase in D.A.

3. The Government have examined the case in detail and are pleased to order that, the special pay granted in lieu of higher time scale of pay and classified under Class I (a)” of Appendix IV, Kerala Service Rules will also be reckoned as pay for purposes of computing the ad hoc D.A. sanctioned in the G.O. read above.

4. The Government Order dated 16-4- 1983 read above will stand modified to this extent.
