**ORDER**

“The General Provident Fund (Kerala Rules)” do not contain a specific provision about the authority competent to sanction Temporary Non – refundable withdrawals to the Heads of Departments

Therefore Government are pleased to issue the following as Government Decisions in the General Provident Fund (Kerala) Rules.

1. Under Rule 16 (1) (a), the following shall be incorporated as Government Decision No. (1) and the existing Government decision renumbered as Government decision (2).

2. Below Rule 28 (B) (1), the following shall be incorporated as Government Decision

“The power to sanction Non – refundable withdrawals in the case of Heads of Departments vests with the Secretary to Government in the concerned Administrative Department of Secretariat For Sanctioning Non – refundable withdrawals involving relaxation of rules or standing orders; concurrence of the Finance Department shall also be obtained”.
