O R D E R

1. The Government Order read above lays down the guidelines for the grant of leave to officers for the purpose of joining their purpose who are abroad or within the country. According to guideline No. (i) only Leave Without Allowances will be sanctioned for this purpose and according to guideline No. (iii) the period of leave will not count for any service benefit.

2. There are certain officers who want to go abroad and live with their spouses for a short period on purely private grounds. Logically, when they have any kind of leave i.e., Earned leave or Half Pay Leave to their credit they should be allowed to enjoy that leave subject to eligibility and other conditions in the rules. But this facility is not now allowed by the G.O. dated 12-4-1984. Accordingly Government are pleased to order that officers who want leave for short periods to join their spouses who are abroad or within the country may be granted eligible leave i.e. any kind of leave other than Leave Without Allowances, to the extent necessary subject to eligibility and their conditions strictly under the rules governing each kind of leave on the specific condition that they should not accept any kind of employment during the period of leave.

3. The above orders will not have retrospective effect. But cases which remain to be decided will be disposed of on the above basis. Cases already settled otherwise will not be reopened.
