PAY REVISION 1983 - SENIOR GRADE FOR ATTENDERS/ CLERICAL ASSISTANTS DRIVERS AND BINDERS ON COMPLETION OF 25 YEARS OF TOTAL SERVICE COUNTING OF PRIOR SECTION UNDER THE LAST GRADE FOR THE PURPOSE OF COMPUTING 25 YEARS OF TOTAL SERVICE FOR ALLOWING THE SENIOR GRADE ORDERS ISSUED.

**ORDER**

In the general pay revision order read as first paper above, at tenders/electrical assistants, drivers and binders were sanctioned a senior grade on completion of a total service of 25 years. The methods of appointment to these categories provide for appointment by transfer free last grade employment provided they possess the requisite qualifications.

Last grade employees are eligible for the grade of Rs. 640-1000 on completion of a total service of 25 years. In the Government Order read as second paper above, it was ordered that in the case of these Last grade employees, who were appointed by transfer to the categories of attenders/ clerical assistants, drivers and binders, they would be allowed the grade of Rs. 640-1000 on completion of a total service of 25 years ie. Service in the category of last grade employees plus their subsequent appointment in a higher order taken together. This concession was allowed on the ground that grade employees appointed by transfer to the above higher orders should not be at a disadvantage on account of such appointment.

It has been represented in Government that if the prior service in the last grade is not reckoned for computing the total service of 25 years, a large number of employees in the categories of attenders/ clerical assistants, binders and drivers will be deprived of the benefit of the senior grade. Government have examined the matter in detail. They are pleased to order that for the purpose of computing total service of 25 years, for senior grade for attenders/ clerical assistants, binders and drivers, their prior service in the last Grade will also be taken into account as a special case. This benefit will be admissible from 16-9-1985, ie. The date on which the senior grade for these categories became available.

Government wish to clarify that the purpose of allowing time. Bound higher grade promotion for 10 years and 20 years of service for the above categories, as at present, only the service in the respective categories will be reckoned.
