- Lower Division Clerk on Rs. 230-385 8. 2 posts
- 9. Chowkidar on Rs. 196-265 1 post.
- Wireless Technician on 345-580 10.
- 11. Draftsman Grade II on Rs. 330-575 1 post.
- Driver on Rs. 215-370 1 post.

The above posts are sanctioned for the period upto 28-2-1979.

The Chief Conservator of Forests (Development) will see that the posts are filled up only according to actual necessity. The posts of Driver and Wireless Technician will be filled up only if an additional vehicle or Wireless sets are actually available.

The expenditure will be met from the plan provision under "313 E (8) Tiger Project (Central Sector Scheme)". As there is only a token provision for the purpose in the current year's budget, the Chief Conservator of Forests will move Government at the appropriate time with proposals for supplementing the provision by re-appropriation or otherwise according to the allocation of Central Assistance available for 1978-1979.
