NOTIFICATION

S.R.O.No. 517/89--- In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Service Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala, hereby make the following rules further to amend the Kerala Service Rules, namely:---

RULES

(C.S.No 459/1989)

1. Short title and commencement:-- (1) These rules may be called the Kerala Service (amendment) Rules 1989.

2. Sub-rule (1) of Rule 2 shall be deemed to have come into force of the 29the day of September, 1986 and sub –rule (2) of rule 2 shall be deemed to have come into force on the 5the day of June, 1985.

2. Amendment of the Rules :-- In Appendix VII of the Kerala Service Rules :-- (i) after sub-rule (ii) of rule 2, the following shall be inserted, namely:--

"Explanation:- The maximum period of absence combining casual leave with Sundays and other authorized holidays will be twenty days at a stretch for the state Government employees working in New Delhi".

(ii) after rule 17 under section II—Special Casual Leave, the following shall be inserted, namely:--

"18. The staff guides, namely teachers in schools and junior lecturers in colleges engaged in the Forest Club activities will be granted two days special casual leave in a calendar year for attending to seminars etc., relating to those activities.

Explanatory Note

(This does not form part of the amendment but, is intended to indicate its general purport)

As per G.O. (Rt) No. 7151/86/GAD dated 29-9-1986 Government have issued orders fixing the maximum period of absence combining casual leave and holidays as twenty days at a stretch for the State Government employees working in Delhi in relaxation of the rules contained in Appendix VII of Kerala Service Rules.

In G.O. (Rt) 1399/85/AD dated 5-6-1985, orders were issued granting two days' special casual leave to the staff guides engaged in Forest Club activities for attending to seminars etc. Government have ordered in G.O. (RT)175/87/FE/WLD dated 3-4-1987 that the category of officers to be posted as staff guides will be teachers in schools and junior lecturers and lecturers in colleges. It was also specified in the G.O. that the total period of special in casual leave that can be granted for the above purpose in a calendar year will be limited to two.

The amendments are intended to give statutory validity to the executive orders already issued
