Persons appointed direct to the personal staff of the Ministers are now Earned leave as per rules in Appendix VIII Kerala Service Rules and it has been pointed out that those who have been continuing in service beyond 5 years without break in the personal staff of Speaker/Ministers/Leader of Opposition/Chief Whip etc., are not getting the benefit of surrender of earned leave as admissible to permanent employees.

Government have examined the matter in detail. As there is no justification for denial of leave benefits to such employees Government are pleased to order that persons who are appointed/re-appointed in terms of Rule 6B of Special Rules and who have put in more that five years service with or without break and of such break is condoned for other service matters as provided in Rule 6 B of Special Rules shall be eligible for leave including surrender of earned leave as admissible to regular Government employees.
