ORDER

In the G.O. read as first paper above it was ordered, among their things, that the officers who were allotted to the Kerala State From the former Madras state consequent on the reorganization of the states and who had opted to the governed by the Kerala Service Rules should forthwith join the State Provident Fund (Tranvancore) subject to the provisions contained in the Note to Rule 22 of part I of the Kerala Service Rules. It was also ordered that the fund balance in the C.P.P.F Account of each subscriber excluding the Government contribution and the interest thereon, would be transferred to the newly opened State Provident Fund Account of the Subscriber concerned. The subscribers were also given facilities for obtaining temporary advances from the C.P.P.F. Subject to the conditions laid down in the C.P.P.F Rules, until they are actually admitted to the State Provident Fund.

- 2. A question has now been raised as to how temporary advances could be granted to those subscribers who have been admitted to the State Provident Fund till the transfer of their C.P.P.F accumulations to the respective State Provident Fund Accounts.
- 3. The Government are pleased to order in consultation with the Accountant General that temporary advances from the State Provident Fund will be granted to such subscribers in accordance with the rules of the State Provident Fund and Subject to the following conditions"-
- (i) The subscribers should have actually been admitted to State Provident Fund and account numbers allotted by the Audit Office.
- (ii) The State Provident Fund Account numbers allotted by the Audit Office should invariably be quoted in the sanctions to temporary advances.
- (iii) Balance in the C.P.P.F Account available for transfer should be furnished in the sanction. This balance may be arrived at by the sanctioning authority after verifying from the Finance Department the balance till the date the accounts are written

up and by checking from records of his office the receipt and payments of the individual subscriber.

- (iv) Copy of sanction in the prescribed from (Form in Annexure IV to G.P.No.Fin. (RC) 3-27466/57 dated 1-1-1957) should be forwarded to the Accountant General as and when sanction is accorded in each case.
- (v) A Certificate should be furnished to the effect that has actually verified the balance as per item (iii) above.
