ORDER

In the Government Order read as first paper above it was interalia ordered that the State Government employed parents of physically handicapped children would be paid Education Allowance @ RS . 100 per month during the schooling up to and including the level of Higher Secondary if such children are receiving instructions or training in some institutions recognized by the State/ Central Governments. Subsequently the above benefit was extended to the State Governments employed parent of mentally retarded children also subject to the same conditions prescribed in the Government Order read as first paper. Thereafter, representations are being received by Government to extend this allowance to the Part Time Contingent Employees for the education of their mentally retarded /physically handicapped children.

Government have examined the matter in detail and are pleased to order that the Part Time Contingent Employees will also be eligible for the Education Allowance @ RS. 100 per month for the education of their mentally retarded / physically handicapped children subject to the same conditions prescribed in the Government Order read as first paper above.

The Order will come into effect from 1-4-2000.
