ORDER.

Consequent on the review of the State IFS Cadre notified by the Government of India vide Notification No.: 16016/8/99----(II)-A dated, 02.11.1999, certain additional posts were encaders and certain existing posts abolished. Orders were issued in the Government order read above accommodating Officers against cadre/ex-cadre posts, after creating ex-cadre posts wherever necessary, Government have since considered the question of accommodating some more officers now holding ex-cadre posts against vacant cadre posts, so that utilization of the State deputation reserve can be brought down.
