As per the Government order cited, the pay scale of L.D. Clerks has been revised form 950-20-1150-25-1650 to Rs.3050-75-3950-80-5230 w.e.f. 01-03-97.

Sri.P.S.Salil, L.D.Clerk office of the Adirappilly Range of Vazhachal Division has submitted an representation for Senior-Junior pay anomaly rectification.

Sri.P.S.Salil, L.D.Clerk Office of the Divisional Forest Office, Vazhachal have opted to change over the revised scale of pay of Rs.3050-5230 w.e.f. 01-03-97 and pay of fixed at Rs.3050/-.Pay after next increment due on 01-01-98 is Rs.3125/-.

As per para 9(1) of annexure 111 of the Go cited, When pay is refixed on the date of next increment due in the pre-revised scale the senior L.D.Clerk of Sri.P.S.Salil (entered in to service on 13-01-95) is drawing less pay than the junior L.D.Clerk Smt.Bindu P.John .She entered into Government service on 16-01-95. Her pay has been fixed at Rs.3050/-w.e.f. 01/03/97 in the scale of Rs.3050-5230.She has availed leave without allowance from 18/01/95 to 30/04/96.There fore her increment due on 28/04/97.Then the pay fixed at Rs.3125/-w.e.f. 28-04-97 and next increment Rs.3200/-w.e.f.01-04-98.

In the above circumstance,I A K Goyal IFS,Conservator of Forests, Central Circle, Thrissur appointing authority of L.D.Clerk hereby order to rectify the

senior-junior anomaly and the pay of Sri.P.Salil , L. D. Clerk is fixed at Rs.3125/- w.e.f.28-04-97 as per para 9(2) of Annexure 111 of the Go 1st and 2nd cited. The next increment shall be granted after completing the required qualifying service, that is on 01-04-98.
