## **ORDER**

In the G.O first cited, orders were issued discontinuing the system of issue of formal orders of sanction to pension under the K.S.R. and amending the form of application for pension (form No.2.K.S.R) According to the revised procedure prescribed in the G.O expect in the G.O expect in the case of family pension and payment of deathcum-retirement gratuity in respect of deceased officers, the sanctioning authority will record its orders in general terms on the pension application itself before forwarding it to the Accountant General for verification of the claim. on receipt of the pension papers passed on to him, the Accountant General will conduct necessary verification and on the strength of the orders recorded on the application by the sanctioning authority he will issue the pension payment Order straight away. The advantage of the revised procedure is that it minimizes delay in the settlement of pension claims. in his letter second cited, the Accountant General has suggested that the new procedure may be adopted in regard to cases of pension or gratuity under the T.S.R, the C.S.R and the M.PC and those of gratuity under certain other specified riles such as the rules for the payment of gratuity to work establishment personnel, contingent employees, non-pension able, contingent employees, no-pension able staff of the Transport Department etc.....The Government are pleased to accept the suggestion of the Accountant General and they order accordingly. The sanctioning authority will adopt with suitable modification the form of advance sanction prescribed in the new form No.2 of K.S.R-vide the annexure to the G.O First cited, for recording their orders on the application for pension or gratuity.
