## <u>Order</u>

The managing Director, The plantation corporation of kerala LTD, Kottayam, has requested Government to depute one Divl .Forest Officer ,One Ranger and one Forest for a period of one month for the conduct of a random survey of certain forest lands in Nilambur which the company proposes to purchase .Govt have considered the question in consultation with the C.C.F and are pleased to pase the following orders.

2. Sarvashri.k. Sankaran Vair, Asst.Conservator ofd Forets (in the scale of pay of nRs.350-700) Hydel Division, Kottayam, C.V.Subramonian, Range Officer (in the scale of pay of Rs115-3000 Trichur divisional and p .Gopinathan, Forests (in the scale of pay of Rs.40-120) Nilambur division are deputed to the plantation corporation of kerala LTD:; For a period of one month from the date of their joining duty subject to the terms and condition mentioned below.

1. The officer shall be paid pay and allowance admissible to state Government employees of the same rank

2. During the period of deputation the officers will draw their grade pay from time to time under Government plus 20% of it as deputation allowance.

3.Leaves salary and pension contribution calculated at  $1/4^{\text{th}}$  (one fourth) of the officers pay and D.P in the State scale from time to time should be remitted by the foreign employer regularly, subject to rules in the matter.

4. The Officers shall be eligible T.A at rates provided under K.S.R.

5. Joining time shall be regulated as provided under K.S.R and Joining time pay shall be not by the foreign employer both ways.

6. The Officer shall be eligible for medical concessions on a not less favorable than under Govt .

7. Leave salary in respect of disability sustained by them in and through Foreign Service even through such disability manifests itself after the termination of such service shall be met by the foreign employer.

8. The whole expenditure in respect of compensatory allowance for periods of leave in or at the end of Foreign Service shall be met by the foreign employer.

9. The expenditure in respect of the difference in-the leave –salary (ie .The difference between the leave salary that the officer would have entitled to hand he continued in government service and the leave salary for which he is eligible in the foreign service) shall be met by the forest officer taking leave after reversion to the parent department, if the difference .in leave salary exist even after such reversion , it shall be recovered from the foreign employer.

10. The general terms and condition s of the deputation shall be as..... down in chapter ii, part i, kerala service rules.

11. The right of the officers will be protected under rule (8) of the kerala state 1 subordinate service rules.

These officers will be under the administrative control of the Managing Director, plantation Corporation of kerala LTD .During the period of deputation .In view of the urgency of the matter the C.C.P is requested to issue immediate instruction to the officer concerned asking them report for duty before the managing Director, Plantation Corporation of kerala LTD.Forth with.

4. Further order of posting and transfer consequent on the deputation now sanctioned will issue from the Agriculture (Forest Establishment Department).
