ORDER

The Managing Director, Kerala Forest Development Corporation Ltd. Kottayam in his letters read above has intimated Government that the Board of Directors of the Company at their 89th Meeting held on 24.2.94 decided to revise the pay scale of the employees in accordance with G.O. (P) 600/93/Fin. dated 25.9.93 and to obtain approval of Government in this regard. The Managing Director has also reported that the company has from its inception been following the same pattern as Government regarding the pay scales and D.A.rules. The 1978, 1983, 1988 pay revisions as effected by the Government were also implemented in the Corporation. The Service conditions of the Corporation was approved Government as per G.O. (MS) 59/86/F&WLD dated 24.6.86 which stipulates that the provisions of Kerala Service Rules regarding general conditions of service, pay fixation etc. are applicable to the Corporation staff also. The staff. Pattern of the Corporation comprises of both deputation lists and direct recruits. Hence the Managing Director has requested to issue orders revising the scale pay of the employees of the Kerala Forest Development Corporation.

Government have examined the proposal of the Managing Director, Kerala Forest Development Corporation on the basis of Government Orders read as 3rd, 4th and 5th papers above, wherein it was ordered that variable DA alone will given to all Public Moreover, no wage revision will allowed in loss making Sector Undertakings. undertakings. It was further clarified in the G.O. read as 4th paper above that the pay

revision based on G.O. (P) 600/93/Fin. dated 25.9.1993 will not be automatically extended to the Public Sector Undertaking based on the decision that variable D.A. alone will be paid to the employees of the public sector undertakings. In the case of Corporation etc. where there is already a pension scheme separate decision will be taken to revise the pay/ DA as in Government, It was also clarified that pay revision will be considered only if the undertaking has not profit for a consecutive period of two years. In the G.O. read as 5th paper above it was ordered that pay revision shall be allowed on completion of 5 years from the date of last pay revision.

3. Government has examined the matter in detail. The Kerala Forest Development Corporation has no pension scheme. The last pay revision was in 1988. In the circumstances Government are pleased to order that the pay scales of the employees of the Kerala Forest Development Corporation Ltd. Kottayam will be revised with effect from 1.3.92 s per clause 3(iii) of G.O. (MS) 12/95/Plg. dated 15.7.1995 as with the rules (except Rule-1) given in the Annexure III to G.O.(P) 600/93/Fin dated 25.9.1993.
