## ORDER

The period of temporary exemption granted to the employees belonging to Scheduled Castes/Scheduled Tribes from passing tests (unified, Special or Departmental Tests) granted in the G. O read as first paper above was extended from time to time. In the G. O read as 2nd paper above, the exemption was made applicable to promotion tests as well as probation tests with effect from 13-4-1983. It was also ordered that new entrants in service after 31.12.1915allowed not be entitled to any test exemption.

2. The period of temporary exemption extended as per the G. O. read as 11<sup>th</sup> paper above expired on 31-12-1996. Government consider it necessary to extend the period further and hence order that SC/ST employees who were in service on 31-12-1985 will be exempted from passing the tests (Unified, special or Departmental) for a further period of one year form 1-1-1997.
