<u>O R D E R</u>

The Principal Chief Conservator of Forests (General) in his letter read as 3rd paper above has reported that there is a need for a well established Project Cell for the implementation of the Kerala Forestry Project which is a World Bank Project. The World Bank had given a Project Preparation Facility (PPF) of Rs.140 lakhs for the preparation of the Project and for conducting studies. The pre appraisal working to be completed before the appraisal. For the efficient functioning of the Project Cell as an office, and carry out the normal office functions certain posts are to be sanctioned.
