In para 15 (a) of the General Pay Revision Orders 3rd cited it has been ordered that the 20 year and 25 year higher grade promotions granted as per G.O.2nd cited would be allowed simultaneously with effect from 16-9-1985 instead of allowing 25 year grade alone in the case of those who had more than 25 years 'service as on 16-9-1985 and who were eligible for both the grades. A doubt has now arisen whether the last grade employees who have enjoyed the benefit of 25 year higher grade before 16-9-1985 in pursuance of the G.O.1st cited are also eligible for the 20 years higher grade with effect from 16-9-1985 in the light of the orders contained in the General Pay Revision Order dated 1-11-1989. Instance of seniors who got the benefit of 25 year higher grade alone getting lesser pay than their juniors who get the benefit of both 20 and 25 year higher grades simultaneously have also been brought to the notice of the Government.

2. Government having considered the question in detail, clarify that those last grade employees who were granted the 25 years higher grade with effect from a date prior to 16-9-1985 vide G.O.first cited can be granted the benefits of 20year and 25 year higher grade simultaneously subject to the condition that the employee refunds in lump the monetary benefits already received on account of the 25 year higher grade. Accordingly, the last grade employees who were allowed the 25 year higher grade on Rs. 640-1000 (prerevised) on a date prior to 16-9-1985 will be allowed the 20 year higher grade G P T.4/3294/MG 2677 will be allowed the 20 year higher grade on Rs. 600-950 and 25 year higher grade on Rs 640-1000 simultaneously with effect from 16-09-1985 or from a date opted by the employee after 16-9-1985 provided the excess amount drawn by him in the 25 year higher grade scale is refunded in lump.
