**ORDER**

In the letter first read above, the Director of Social Welfare has forwarded a proposal to grant an extra time of 15 minutes per hour in the examinations including departmental tests conducted by the Public Service Commission to the orthopaedically handicapped candidates who cannot freely use their hands. Government after having examined the matter in consultation with the Public Service Commission and the Director of Health Services are pleased to order that an extra time of 15 minutes per hour will be granted to orthopaedically handicapped candidates in all examinations including Departmental Tests conducted by the Public Service Commission, subject to the following conditions:-

- (i) The above concession will not be allowed in the case of examinations which are fully objective.  
(ii) The percentage of disability and the fact that the candidate cannot write at normal speed should be specifically mentioned by the

Orthopedic Surgeon/Specialist in Physical Medicine and Rehabilitation (Physiatrist) in the medical certificate, which should be in the form attached to this order.


(iii) The candidate should obtain the medical certificate in the prescribed form and attach to the application when it is submitted to the Kerala Public Service Commission.
