ORDER

In the G.O.read as 2nd paper above, orders have been issued to the effect that The arrears of salary and allowances due to Pay Revision 1988 for the period from 1-7-1988 to 30-11-1989 should be claimed as part of the salary bill for any Of the months from February 1990 to August 1990 payable from March 1990 to September 1990 and credited to the Provident Fund Accounts of the employees Concerned. It was also ordered therein that for claiming salary for the month of Month of September in October, 1990, a certificate should be attached to the salary Bill that the arrears for the period from 1/7/1988 to 30/11/1989 have been claimed and credited to the G. P.F. Account of the employee concerned.

2. Government have received several requests to extend the above period for Crediting the arrears of salary due to pay revision 1988 for the period from 1-7-1988 to 30-11-1989.

3. Government have examined the matter and are pleased to order that the Arrears due on account of Pay Revision 1988 for the period from 1-7-1988 to 30-11-1989 may be claimed as part of the salary bill for any of the months up to the bill for December 1990.

4. For claiming salary for the month of December 1990 in January 1991 the Certificate mentioned in para 2 of the G.O.Second cited may be furnished in the Pay bill for December 1990.
